THENCE North 17 degrees 23 minutes West along the east line of said "Roosevelt Drive" right-of-way and the west line of said Lot 1, Block 3, for a distance of 283.51 feet to a point for corner, said point being the southwest corner of the Roosevelt Drive and Clover Lane rights-of-way, and said point also being the northwest corner of said Lot 1, Block 3;

THENCE continuing North 17 degrees 23 minutes West along the east line of said "Roosevelt Drive" right-of-way, and the west line of said Clover Lane for a distance of 62.95 feet to a point for corner, said point being the northwest corner of the said Roosevelt Drive and Clover Lane rights-of-way, and said point also being the southwest corner of Lot 8, Block 2, of the said DHA plat;

THENCE continuing North 17 degrees 23 minutes West along the east line of said "Roosevelt Drive" right-of-way and the west line of said Lot 8, Block 2, for a distance of 363.15 feet to a point for corner;

THENCE North 0 degrees 40 minutes East along the east line of said "Roosevelt Drive" right-of-way and the west line of said Lot 8, Block 2, and continuing along the west line of Lot 1, Block 2, of the said DHA plat for a distance of 917.90 feet to a point for corner, said point being the northwest corner of said Lot 1, Block 2, said point being the northeast corner of said "Roosevelt Drive" right-of-way, and said point also being in the south line of said Arkansas Lane right-of-way;
