3. Discuss and consider staff recommended changes to Chapter 14 of the City Code of Ordinances.

City Secretary Lola Hazel presented the proposed changes to Chapter 14, Zoning, regarding mobile food units and mobile food establishments.

Background on this item: The Dalworthington Gardens Planning and Zoning Commission ("The Commission") met in September, November, and December 2017 to give staff direction on a mobile food truck ordinance. The Commission indicated that the zoning ordinance for mobile food trucks should substantially remain unchanged with the exception of some minor revisions to the definitions, and permitting process. The Commission approved recommended staff changes with additional edits, all of which were finalized in ordinance form. The final ordinance was submitted to City Council (Council) on January 18, 2018. Council suggested additional revisions to the ordinance which requires the Commission to hold a meeting to consider such revisions.

The revisions submitted to the Commission included revised definitions, requirements for residential zoning districts, changes to permit requirements, and changes to the fee schedule. The Commission felt residential districts should have minimal restrictions for mobile food units and made changes to reflect same.
