He is 1 of 16 umpires from around the world who will participate in these games in Williamsport, PA. Serving as an umpire at the Little League World Series is the dream of every local league volunteer umpire.



The selection process to become a World Series umpire is lengthy and rigorous. In order to be eligible to volunteer in a Little League World Series, an umpire must first have officiated in multiple levels of local, state, and regional tournaments. Individuals who meet those qualifications are then screened annually by Little League and region staffs for selection to umpire in a Little League World Series tournament. Appointment as a member of the umpiring crew for a World Series is the highest honor that Little League can bestow on a volunteer umpire.

Larry has been a volunteer umpire with Little League and ASWLL for over 20 years, giving countless evenings and weekends to give back to the families in the Arlington community. Larry is the Umpire-In-Chief (UIC) for training and development for new umpires in ASWLL and neighboring little leagues. He regularly spends additional time and personal funds attending training and traveling throughout Texas to officiate in other Little League tournaments. **Garbage and Recycling Services:** Just a reminder, the City is switching to Commercial Waste Disposal (CWD) for garbage, recycling, and household hazardous waste and electronics collection services on September 1, 2023. Garbage service will remain as bagged service for residential customers and collection remains on Tuesdays and Fridays. Residential recycling services remain as cart services but moves to a 95-gallon capacity cart. For cart transition, CWD will be delivering recycling carts on Tuesday, August 29. If you are currently paying for an additional cart, that will be delivered the same week. Republic Services will be removing their cart on August 29, so please leave your Republic cart at the curb after collection. Recycling services are moving to Friday beginning September 1, 2023.

**Roosevelt Foot Bridge:** You may have noticed one of the foot bridges on Roosevelt Drive is coned off and the bridge is missing. Staff began work on the bridge in-house, and during those efforts, ran into structural concerns leading to full removal of the bridge and marking off the area from use. Because the new and improved bridge requires engineering, design, and fabrication upon order, it will not arrive until early 2024. Although we would like the bridge to arrive sooner, we feel the result will be worth the wait. We do appreciate your patience.

**New Billing Schedule:** Just a reminder, the City will be changing utility billing dates to move to calendar month billing. This will result in being billed on August 16 for service dates of 7/17/23-8/13/23 and a short billing on September 5 for 8/14/23-8/31/23. Bills will then move to the 1st part of the month with a due date at the end of the month (October 4 billing will be due October 30). We understand this may result in unexpected expenses with two back-to-back billings and moving to a new schedule. +++++DID YOU KNOW +++++

Monarch butterflies should begin to float through our area at the beginning of September on their migration to their overwintering grounds in Mexico. You can help support their fall migration by having nectar plants blooming in your garden to fuel their migration. The generation of butterflies that migrate through in the fall is in a state called reproductive diapause that allows them to make the long trip. If they encounter milkweed in the fall, it can break them out of diapause and disrupt the migration cycle.
